



FEES FOR OFFICIAL MASTER'S DEGREES AT THE UNIVERSITAT POLITÈCNICA DE CATALUNYA FOR THE 2025-2026 ACADEMIC YEAR

Introduction

The Universitat Politècnica de Catalunya (UPC) offers its higher education services via public funding and the payment of the fees (by students) set by the competent administration, in this case the Generalitat de Catalunya.

In the latest report published by the Generalitat de Catalunya on the cost of university degrees, the total cost of a year of a master's degree is €13,803.¹

The decree regulating the public prices applied in a given academic year is published a few weeks before the start of activities. This means that, at the time of admission to master's studies, the information on final prices is indicative. Despite the above, given that Price Decree 125/2025 was published on June 20, 2025, this document refers to the public prices for the 2025-2026 academic year (latest fixed prices).

Fee structure

Master's programmes are organised and enrolled for in credits. The amount to be paid by the student mostly depends on the number of credits enrolled. Credits for subjects that have been failed beforehand are subject to a surcharge that depends on whether they are being enrolled in for the second, third or fourth time. A full academic year is quantified as 60 credits.

If the decision on admission states that the student must take bridging courses, the corresponding credits must be paid as master's degree-level credits and therefore the fees of the master's degree being taken will apply. These credits do not in any way substitute for the total number of credits that make up the master's degree and that the student must pass.

The decree on fees sets different fees for qualifying master's degrees that make the holder eligible to practise a regulated profession, (<https://www.upc.edu/es/masteres/programas-integrados>) and other, non-qualifying master's degrees.

The decree on fees establishes that the UPC's Board of Trustees may set different fees for non-resident foreign students who are not nationals of countries in the European Union or of countries to which the community regime applies.

Estimated fees for a master's degree at the UPC

On the basis of the information provided above and current fees, the estimated fees for an official master's degree according to its type, organisation and number of credits are the following:

Once again, it is important to note that the real cost of fees each year will depend on the number of credits students enrol in and whether they are enrolling in them for the first time or subsequent times. The total cost of fees increases if the credits are being enrolled in for the second, third or fourth time, according to students' performance. The total fees for the master's degree may increase if students have to take bridging courses.
